Eligibility:

1. Student must be from minority community who has scored more than 50% marks in the previous examination
2. Annual income of the parents / guardian should not exceed Rs.1 lakh
3. Scholarship will be available for a maximum of 2 students in a family

How to Apply?

1. Visit www.scholarships.gov.in website.
2. **In Case of Fresh:** Select **“New User? Register now”** option.
Fill in the Registration form, click **“Register”** Button.
Note down Application Number which is displayed.
Select **“Apply for Fresh”** option from the menu & enter Application Number which is displayed after registration and Password (Date of Birth).
In Case of Renewal: Select **“Apply Renewal”** option.
3. Self-attested copies of the following certificates should be submitted to the school.
 - a. Submitted Application Form
 - b. Student Photo
 - c. Previous year mark statement
 - d. Income certificate
 - e. Community certificate
 - f. Fee Receipt of current course year.
 - g. Proof of Bank Account in the name of student(where students do not have their own bank account number parent's account number can be used. However, parent's account number can only be provided for maximum of their two children.)
 - h. Aadhaar Card (If Aadhaar is not available, then Bonafide student certificate from Institute / School)
 - i. Address Proof
